INVESTIGATION

VICT-KATRINA STATED THAT ON 3.16.11 AT APPROX 1600 HRS SHE & A FRIEND (NFO) WERE HAVING A BUSINESS MEETING AT SPORTS CLUB L.A (1835 S. SEPULVEDA). KATRINA THEN GAVE A SHORT TOUR OF THE GYM TO HER FRIEND WHEN SHE NOTICED SUSP-WIDOM STANDING & FOLLOWING HER.

VICT-KATRINA STATED THAT SUSP-WIDOM WAS AN ATTORNEY THAT WAS TERMINATED FROM A LAW FIRM, IN WHICH HER HUSBAND (WOOLGASTEN, GEORGE) IS CURRENTLY EMPLOYED AT. SHE EXPLAINED THAT WIDOM WAS CURRENTLY IN LITIGATION, WHERE HE WAS SUING THE LAW FIRM, FOR WRONGFUL TERMINATION, KATRINA INFORMED THAT SINCE HIS TERMINATION (4'09) SHE HAD BEEN FOLLOWED HOME BY HIM APPROX (7) TIMES FROM THE SPORTS CLUB, LA. SHE EXPLAINED THAT THEY ARE BOTH MEMBERS AT THE GYM & WHENEVER THEY WERE BOTH THERE HE WOULD FOLLOW HER.

VICT-KATRINA STATED THAT ON ABOVE DATE SHE ATTEMPTED TO WALK AWAY FROM WIDOM. WHEN HE APPROACHED HER & STATED, "I AM GOING TO HURT YOU! I'M GOING TO GET YOU! I'M GOING TO GET GEORGE OUTSIDE OF THIS LITIGATION!" KATRINA RESPONDED, "I KNOW YOU HURT USA! (SUSP'S WIFE) I WILL NEVER LET YOU HURT ME! I WILL CALL THE POLICE!" WIDOM THEN STATED, "I'M NOT AFRAID OF THE POLICE. I'LL GO WHEREVER I WANT & I WILL DO WHATEVER I WANT, INCLUDING COMING TO YOUR HOUSE!"

VICT-KATRINA THEN RAN TO MANAGEMENT OFFICE FOR HELP. SHE STATED THAT TRAINER (DIMUZIO, MARK 310-403-1197) WAS PRESENT DURING ABOVE INC. KATRINA WAS IN FEAR FOR HER SAFETY & STATED THAT SHE DID NOT REPORT THIS INC EARLIER TO POLICE, DUE TO THE FACT, THAT SHE DID NOT
